

Investigating the Rights of the Bisexuality children in Iran

Human beings are born or son or daughter, but rarely there are exceptions to this procedure and the sex of the child is born. For clarification of this group of people in 1364 after sex determination with regard to forensic medicine, surgery, legal aspects, and for the first time, was a sex change. Neutral in religious texts called bisexuals, people who have one or more attributes of both male and female. Sexual changing of the people causes the emergence of evidence or sign of the opposite sex comes constant. The people in accordance with Article 939 of the Civil Code inherited texts and half of men and women is the total inheritance. Introduction

The Kinsey Reports are two books on human sexual behavior: *Sexual Behavior in the Human Male* (1948) and *Sexual Behavior in the Human Female* (1953), written by Alfred Kinsey, Wardell Pomeroy and others and published by Saunders. Kinsey was a zoologist at Indiana University and the founder of the Kinsey Institute for Research in Sex, Gender and Reproduction (more widely known as the Kinsey Institute).

Sexual Behavior in the Human Female was based on personal interviews with approximately 6,000 women. Kinsey analyzed data for the frequency with which women participate in various types of sexual activity and looked at how factors such as age, social-economic status and religious adherence influence sexual behavior. Comparisons are made of female and male sexual activities. Kinsey's evidence suggested that women were less sexually active than men.

The publications were immediately controversial among the general public. The findings caused shock and outrage, both because they challenged conventional beliefs about sexuality and because they discussed subjects that had previously been taboo.

Kinsey's methodology used to collect data has received criticism. It has been suggested that some data in the reports could not have been obtained without collaborations with child molesters.^[5] The Kinsey Institute denies this charge, though it acknowledges that men who have had sexual experiences with children were interviewed, with Kinsey balancing what he saw as the need for their anonymity to solicit "honest answers on such taboo subjects" against the likelihood that their crimes would continue. Additionally, concerns over the sample populations used were later addressed by the Kinsey Institute. The conclusion of the Kinsey Institute was that none of Kinsey's original estimates were significantly affected by these data sources

Bisexuality is romantic attraction, sexual attraction or sexual behavior toward both males and females, and may also encompass romantic or sexual attraction to people of any gender identity or to a person irrespective of that person's biological sex or gender, which is sometimes termed pan sexuality

Sexual identity is the product of countless imitators of family members, teachers, friends and business cultural phenomenon fitted. The formation of sexual identity, and cultural attitudes of parents, children's organs and genetic factors play a role that is physiologically active until the sixth week of fetal life. The subject of sex Transgender people may want to have at least one of the following groups:
1 bisexual These people are the genitals of both sexes have a gender identity disorder or Gender ambiguity.
2 transsexual: This group of heterosexual know the psychological point of view, these experts are sharp differences of sex. Some of these patients have no health psychologists to some but not sex. Almost all Sunni scholars and Christian churches disagree with this surgery. But with the large number of Shiite jurists agree with the following two conditions

First condition: transformer condition is true and certain, suspects are not allowed to change gender.

Second condition: transsexuals have to be perfect. Man becomes a woman or vice versa.

The legal status of bisexual child

- C) providing legitimacy theory

B mode: In this mode, the probability is: 1: parents change their gender, their child will inherit the relationship comes off completely

This possibility is unlikely. It is not the barrier is inherited as a sex change. the Civil Code of the Islamic Jurisprudence, in cases of inheritance refers obstacles. In Article 880, stated: "The murder of obstacles inheritance ..." Article 881 stated: "infidel inheritance of certain ..."; and in Article 882 and 883 to prevent the "Lan" and "deny causality" refers, in Article 884 refers to illegal children.

Possibility 2: A second possibility is that the inheritance. But chances are there two bases: the first inherited in time reproduction. The second priority inheritance and kinship terms

Article 1181 of the Civil Code, stated: "Each of the children to their fathers and grandfathers have province" and Article 1182 of the Civil Code, stated: "Whenever a child is the father and both grandfathers and one of them is incapacitated or prohibiting the cause of the seizure of the property against the Lord, he overthrew the legitimate province of the screw, "and in Article 1185 of the Civil Code to-read:" Whenever the guardian of the child is incapable of public prosecutor is obliged to comply with the regulations referred to appoint a guardian, supervisor given to the child

Second case: the father of the female sex change, in this case there are two theories:

The first: "If heterosexual men change, it appears that the guardianship of the children-is toppled

The reason for the above proposition can be stated:

Based on 25 years of research that focuses on this problem , there are several theories in the field.

The main problem is that surgery alone helpful in treating mental and social factors as well as an integral part of the treatment process that is constantly in motion. These people are ridiculed as a child in school pick-and in some cases physical or sexual abuse, and therefore, they would-be suspended..Studying the older in universities is also very difficult and also finding a job is difficult for them.

Some children's behavior problems are easily solved and some of them are required to visit a professional experts. Such as:

1.self-abusive behaviors, these behaviors can lead to injury or even death, and it should never be ignored. Threatening words from the children to the attention of the parents is a warning that should be taken seriously. Risk of suicide should be taken very seriously.

2.Strange behaviors: behaviors that are so strange and unusual that you have to eliminate all their effort. Such as hallucinations, strange noises, the constant wearing clothes of the opposite sex or wishing that I had sex, sexual narcissism clothes and ...

Maintaining open communication between parents and children is very important, we must ask the children to share with us your thoughts and feelings in order to understand them and to help them up and living in crisis

Conclusion

Transgender, if in compliance with all standards of medical specialists in the diagnosis performed in accordance with the rules and legal principles and not inconsistent with public order and good morals. Therefore, it is

necessary to pay attention to the following key:

- Raising public awareness through mass media about the sex of the patients.
- De-stigmatization of patients.
- support the patient in order to adapt them to their own gender.
- Establish a scientific point of view of human and political authorities looked into the doctrinal approach to patient sex.
- support the patient's sex and the prevention of discrimination and injustice imposed by the recruitment of patients in government jobs.
- providing assistance and advice.
- providing the necessary training to prevent risky behaviors
- provide the necessary funding by the government to provide portion of health care costs for these patients.
- provide training on new roles and skills necessary social acceptance of transsexuals.
- helping to provide temporary housing for these patients in the absence of family support.
- provide information to the families of the patients on admission to the difficult living conditions of children and to prevent their exclusion.
